Applies to expired inspection if certificate had not been expired more than 60 days.

NOTE: False statement to a registration clerk is a felony offense.

Time Payment Reimbursement fee (Article 102.030 Code of Criminal Procedure)

Municipal Court shall collect a fee of \$15.00 from a person, who has been convicted, pays any part of a fine, court cost or restitution on or after the 31st day after the date Judgment is entered.

Renewal of your driver's license may be denied if you fail to appear in court. EFFECTIVE: 09/01/2003.

1. If you wish to enter a plea of NOT GUILTY and desire a trial, advise the court by checking a plea on or before the appearance date. You will be notified by the court when to appear for trial and specific requirements of the particular court bail requirements, etc.

2. DRIVING SAFETY COURSE:

A CHARGE MAY BE DISMISSED BY COMPLETING A DRIVING SAFETY COURSE IF:

- 1. You were not driving any motor vehicle while licensed with a CDL.
2. The alleged speed is not 25 mph or more over the posted speed limit.
3. You have not used this option during the preceding 12 months & are not in the process of using this option for another offense.
4. You have a valid Texas Driver's License or permit.
5. You provide the court with proof of financial responsibility (liability insurance) that complies with state law.

3. If you wish to ENTER A PLEA OF GUILTY OR NOLO CONTENDERE, please indicate in the proper space provided. A plea of Nolo Contendere means that you do not contest the state's charge(s) against you. The fine and conviction for a NOLO CONTENDERE plea is the same as that of a plea of Guilty. Either plea indicates that you agree to waive appearance before the Court of Trial.

4. If you FAIL TO RESPOND to the charge(s) ON THE APPEARANCE DATE SHOWN ON THE CITATION, an additional charge may be filed against you for Failure to Appear and warrants issued for your arrest. (WARRANT FEES OF \$50 will be issued on each charge for EXECUTING OR PROCESSING A WARRANT.)

5. PLEASE NOTE: the judge cannot discuss the merits of a pending judicial proceeding prior to trial (Canon 3(5), Code of Judicial Conduct). This means the judge cannot discuss your citation with you before trial.

6. A JUVENILE who fails to appear (a parent or guardian must appear if Juvenile is under 17) by the time/date on a citation may have their driver license suspended as required by law.

REQUEST FOR DEFENSIVE DRIVING

I hereby enter my appearance on Citation # ... I understand that I have the right to a jury or bench trial. I hereby waive my right to a trial, plead "NO CONTEST", and request to take a driving safety course.

I understand that I must first:

- 1. Present to the court a valid TEXAS driver license or permit.
2. Present to the court proof of financial responsibility (insurance).
3. Pay court costs & non-refundable \$10.00 fee (Total \$144.00) or (\$169.00)- School Zone.

I understand that:

- 1. If I complete & turn in my certificate & driving record within 90 days, the charges against me will be dismissed & that the court will report to DPS the completion date of the driving safety course for inclusion on my driving record.
2. If I fail to present to the court proof of completion of the driving safety course & certified driving record within 90 days, the court will require my appearance at a show cause hearing.
3. If I fail to appear at the show cause hearing, the court will impose a fine and may issue a warrant for my arrest.
4. By signing below, I affirm that I have not taken a defensive driving course within the last 12 months.
